1. Based on the **E-registration forms/off-line application forms** received from the students, End-Term Examinations (Law Programs) are to be scheduled from 28th -31st December 2015 onwards.
2. **1st and 2nd January, 2015 are reserved for conduct of repeat/improvement/ re-registration examination. For appearing in repeat/improvement/RR examination, a student is required to submit application form on or before 30th October, 2015 so that they may be communicated timing of their repeat/improvement examination on 1/2 January, 2015.**
3. Students willing to appear in December, 2015 main examinations shall fill-in on-line application form available at Distance Education-Law Program-Important Notification link, or, download the file of E-Registration form given at Page No.2; and send it to the DE office via return mail.
4. All students shall submit the completed examination-form through e-mail to the office (distancenlujod@gmail.com) on or before 21st November, 2015 (5.00 p.m.).
5. Examination form shall not be accepted after 21st November, 2015 (5.00 p.m.).
6. **Last date of submission of completed assignments is 15th December, 2015. Request for extension of date of submission of assignment will not be accepted.**
7. This process will enable the office to arrange facilities of accommodation, mess etc. in a better way for the DE students.
