The admission is based on CLAT merit and subject to fulfilling the eligibility conditions. There is no specific intake for individual specialization.

ELIGIBILITY

A candidate should have passed the LL.B./B.L. Degree or an equivalent Degree from a recognized University with not less than 55% marks in the aggregate.

RESERVATION

15% and 7.5% seats in all courses individually will be reserved for SC and ST candidates respectively. A relaxation of 5% of marks in the eligibility criteria will be admissible to candidates of these categories. 3% seats in each category are reserved for physically challenged candidates.
