The Committee has been constituted vide order dated 21 November, 2025 by the Hon'ble Supreme Court of India in Suo Moto Writ Petition (Civil) No(s). 8 of 2025- In Re: 2 Million Lives at Risk, Contamination in Jojari River, Rajasthan under the Chairpersonship of **Hon'ble Mr. Justice Sangeet Lodha**, Hon'ble (Retd.) Judge of High Court of Judicature for Rajasthan and various authorities as Members of the Committee.

Therefore, the University invites applications for **01 (One) Law Research Scholar** towards research, preferably, in the subject/area of Environmental Law.

Responsibilities: Research Scholar would undertake research and assist the Committee in relevant areas in consultation with the Hon'ble Chairperson of the Committee.

Eligibility: LL.M. (preferable in Environmental Law) from a reputed Indian or foreign university with minimum 55% marks (or an equivalent grade in a point scale wherever grading system is followed), and a good academic record, or equivalent qualification/experience in the field of research in Environmental topics. There must be a clear and demonstrable track record of interdisciplinary research involving environmental law. Prior research experience including field work & data collection, good analytical & writing skills, proficiency in MS Office is desirable.

Consolidated Amount: INR 50,000 per month (All inclusive) (to be paid by Municipal Committee Jodhpur)

Nature of Appointment: Contractual (For Six Months)(extendable, if required)
