1. ACADEMIC SCHEDULE FOR SESSION 2025-26

The academic schedule for the Academic Session 2025-26 commenced with effect from July 10, 2025. The University has a rigorous schedule of study for 18 weeks during every semester over and above as mandated by the UGC. Academic facilities remain open on the weekly and public holidays as well.

Under Graduate and Post Graduate First Semester classes commenced from August 1, 2025 after the completion of admission process through CLAT and a week-long Deeksharambh 2025.

6. REPORT ON LEGAL AID & AWARENESS COMMITTEE (LAAC) REPORT

i. Legal Awareness Programme Empowers School Students

LAAC organized an awareness programme for students of Eklavya Model Residential School (EMRS) from Sarada, Udaipur on the 10th of January, 2025. The programme saw the willing attendance of students from classes IX to XII, who were exposed to general topics such as the Juvenile Justice Act, cybersecurity, and available career options in the legal profession.



ii. Awareness Program on the Protection of Children from Sexual Offences (POCSO) Act

LAAC, in collaboration with Vishwas Lok Seva Sanstha, organized an impactful legal awareness program on the Protection of Children from Sexual Offences (POCSO) Act. Conducted on January 26, 2025, across three schools in Jodhpur, this initiative aimed to educate school children about their rights, legal protections, and the mechanisms available to them under the POCSO Act.

iii. II-Edition Of NLUJ Right To Education Paper Presentation & Discussion Series

LAAC organised the 2nd Right to Education (RTE) Paper Presentation and Discussion Series on February 8 and 9, 2025. The event was held in collaboration with Indus Action, a nationally recognised policy implementation organisation that works to ensure the enforcement of welfare rights for underprivileged families. Through paper presentations, expert panel discussions, and interactive

workshops, participants explored key policy gaps, legal frameworks, and practical strategies aimed at improving access to quality education for disadvantaged children. The event sought to bridge academic inquiry with field-level realities, reaffirming the university's commitment to promoting legal awareness and social justice.



iv. Participation in II Edition of Tabar Mela By Indeed Foundation

LAAC, in collaboration with the Indeed Foundation, successfully organised the second edition of "Tabar Mela" on February 11, 2025, at Mahatma Gandhi Government School, Chainpura. As a flagship community outreach initiative, "Tabar Mela" aimed at promoting legal literacy and social awareness among schoolchildren through creative, participatory, and experiential learning techniques.



v. Visit of the Delegates From the Office of Attorney General of Nepal to Surpura under the ITEC Programme

LAAC had the distinct honour of hosting a delegation from the Office of the Attorney General of Nepal as part of the Special Training Programme on Artificial Intelligence and Emerging Technologies. This programme was organised under the Indian Technical and Economic Cooperation (ITEC) initiative of the Ministry of External Affairs, Government of India. The visit was a significant component of a broader two-week training initiative aimed at encouraging bilateral learning and fostering institutional exchanges between India and Nepal. The objective of the visit was to offer the delegates an immersive experience into community-oriented legal aid initiatives and the role of clinical legal education in transforming rural legal landscapes.



vi. Story Telling Session at Surpura Community Library

LAAC organized a vibrant Storytelling Session at the Surpura Community Library on March 8, 2025, to foster literacy, creativity, and legal awareness among students of Surpura Government School. The event was part of NLU Jodhpur's broader Smart Village Initiative, through which the university adopted Surpura village and constructed the community library to promote educational infrastructure and community-driven development. By revitalizing the library as a hub for learning, LAAC aimed to increase footfall, encourage regular use of the facility, and inspire young minds through interactive engagement.



vii. Nukkad Natak on Workers' Rights

LAAC organized a Nukkad Natak (street play) on 9th March 2025 at Basni Colony, Jodhpur, in collaboration with the Aajeevika Bureau, as part of the Worker's Safety Week initiative. The primary objective of the street play was to spread legal awareness among industrial workers regarding their rights and entitlements under the Employees' State Insurance Act, 1948, and the Employees' Compensation Act, 1923.



viii. Certificate Course for Women for Justice Fellows

LAAC, in collaboration with Aajeevika Bureau, successfully organized and concluded a five-day certificate course designed for the Women for Justice Fellows from 19 to 23 July 2025. The certificate course offered comprehensive training across multiple branches of law, including labour law, family law, constitutional law, consumer protection law, and POCSO. Sessions were delivered by distinguished faculty members of NLU Jodhpur. In addition to classroom learning, the fellows received hands-on exposure through structured visits to the Rajasthan High Court, Family Court, and the Labour Department. The course further included interactive sessions with eminent judges and practicing advocates, offering valuable insights into litigation, adjudication, and legal outreach.



ix. 2-Day Workshop on Legal Ethics, Client Interviewing Skills and Global Skills for Attorneys

LAAC organised a Special Lecture Series on Legal Ethics, Client Interviewing Skills, and Global Skills for Attorneys, led by Dr. Danixia Cuevas, Professor of Law at Miami Dade College, U.S.A on 1-2 August, 2025. The sessions aimed to bridge the gap between theoretical legal knowledge and practical lawyering skills, equipping students with the tools necessary for ethical and effective legal practice. This initiative aligns with the University's objective of preparing students to engage with real-life legal issues, support vulnerable communities, and develop a strong foundation in ethical conduct and global legal perspectives.

x. Stall at Ashok Udyam - Independence Day Celebrations

A stall was set up at Ashok Udyam on 14 August, 2025 during the cultural programme organised as part of the Independence Day celebrations which was graced by the presence of Hon'ble Chief Minister of Rajasthan, Shri Bhajan Lal Sharma. The stall served as a platform to showcase the University's institutional achievements and commemorate 25 years of excellence in legal education and research. The distribution of carefully crafted placards on cybercrime, POCSO, and domestic violence successfully conveyed critical legal awareness messages to attendees. The stall at Ashok Udyam was a successful initiative in promoting legal awareness, women entrepreneurship, and institutional achievements. The positive reception from the public indicates the effectiveness of such outreach platforms in reaching diverse audiences and building an informed citizenry aware of their legal rights and available support systems.

xi. Nukkad Natak on Cyber Crime and Security at Ghantghar, Jodhpur

LAAC in collaboration with Vishwas Lok Sewa Sansthan NGO, organized a Nukkad Natak (street play) at Ghantaghara, Jodhpur on 31 August, 2025. The primary objective was to promote awareness and educate the local community about the ongoing types of cybercrime in the society like OTP Scam, fake job scam, Shopping frauds, social media frauds, and how we can create a safety net around it, or what steps one can proceed if he or she becomes a victim of the same.



xii. **Awareness Sessions on Cybersecurity and Law as a Career**
LAAC conducted two school interaction programs aimed at introducing students to Law as a Career and raising awareness about Cyber Crime on 20 September, 2025.

xiii. **Legal Aid Outreach during the Vraksh Mela at AFRI**
LAAC organized a legal aid and awareness camp during the Vraksh Mela organized by the Arid Forest Research Institute (AFRI), Jodhpur, along with the Indian Council of Forestry Research and Education (ICFRE), on 23rd September, 2025. The primary objective of the outreach was to provide actionable information on three key aspects to the community namely Government Schemes for Farmers, Right to Education Act Awareness and Free Legal Aid services.

xiv. **Observational Visit to Lok Adalat, Jodhpur**
LAAC undertook an observational visit to the Lok Adalat convened at the District Court, Jodhpur on 13 September, 2025. Lok Adalat's are ordinarily organized four times a year, and the sitting on this date provided a valuable opportunity to witness the forum's functioning firsthand. Our objective was purely observational: to understand the workflow from case intake to settlement, and to interact with stakeholders involved in delivering accessible, speedy justice.

xv. **Legal Awareness Podcast: Rights of Gig Workers**
LAAC collaborated with Prasar Bharati's All India Radio (Aakashvani Jodhpur) to broadcast a special legal awareness episode on 13 October, 2025. The episode focused on the "Rights and Legal Awareness of Gig Workers," addressing the lives and challenges of millions of individuals from delivery partners and cab drivers to freelancers who often operate outside traditional labour protections. The discussion demystified the legal landscape, specifically highlighting the Social Security Code, 2020 and the Rajasthan Platform Based Gig Workers Act, 2023 and emphasized the importance of the e-Shram Portal for accessing insurance, health, and pension benefits.

xvi. **Shilpjeevika Stall at Yuvardha VIII**
LAAC collaborated with Hamara Saahas to set up a stall on campus during Yuvardha-8 from 9-11 October, 2025. The stall showcased handcrafted products of Hamara Saahas including bookmarks, soft toys, bangles, tote bags made by women and children. Hamara Saahas is a team of dedicated courageous women who defy cultural bias and instil confidence in the local women and children of Jodhpur.

xvii. **Second Stakeholder's Summit on Juvenile Justice**
LAAC organised the Second Stakeholder's summit on Juvenile Justice to mark ten years of the Juvenile Justice (Care and Protection of Children) Act, 2015 on 2 November, 2025. The main aim of the summit was to highlight the urgent need for strengthening rehabilitation and reintegration mechanisms for juveniles in conflict with the law. The day also included a Capacity Building Workshop led by Dr. Asha Mukundan, Mr. Govind Beniwal, who serves as a Child Protection Officer at UNICEF India, and Mr. Ashutosh Srivastava, who works as a State Consultant at UNICEF India. The workshop addressed the need for robust support services for child victims, the influence of media narratives on public perception, and systematic gaps in rehabilitation.

xviii. **Project Prism**
Project Prism is based on a detailed proposal submitted to the Azim Premji Foundation for a grant. Based on the theme of strengthening access to justice for undertrial prisoners, the project focuses on addressing delays caused by lack of legal aid, administrative gaps, and socio-economic vulnerabilities. Project PRISM is set to begin as a phased initiative aimed at improving access to justice and safeguarding the rights of undertrial prisoners.

xix. **Project Unnati – English Empowerment Initiative**
Project Unnati is one of LAAC's flagship initiatives, reflecting the Committee's vision of using education as a tool for empowerment and social transformation. The project aims to bridge educational gaps by

providing foundational English language skills to children, fostering confidence, creativity, and disciplined learning habits. The project was conducted over 11 two-hour sessions with 62 students from grades 6–8. The primary objectives were to deliver structured English language teaching, enhance reading, listening, writing, and speaking skills, build communicative confidence, and create a measurable learning journey in alignment with the Right to Education. Implementation followed an interactive, activity-based approach using a specially designed coloured booklet covering basic communication, self-introduction, reading skills, and comprehension. Classes were held twice a week, supplemented by worksheets and continuous informal assessment focused on comprehension, pronunciation, and participation.

7. XVII CONVOCATION

The University hosted the XVII Convocation for the Graduating Batch of 2024 on 23 February, 2025. The momentous occasion was graced by the presence of Shri Bhajanlal Sharma, Hon'ble Chief Minister of Rajasthan as the Chief Guest and Hon'ble Mr. Justice Sandeep Mehta, Judge, Supreme Court of India as the Guest of Honour. The Convocation was presided over by Hon'ble Mr. Justice Manindra Mohan Shrivastava the then Chief Justice, High Court of Rajasthan and Chancellor, NLUJ. The progress report of the University was delivered by Vice Chancellor Prof. (Dr.) Harpreet Kaur and the ceremonial programme was conducted by the Registrar Dr. Sunita Pankaj. 116 students of the Under Graduate batch, 56 post graduate students and 9 Doctoral scholars were awarded degrees during the XVII Convocation.

8. ORIENTATION FOR NEWLY ADMITTED STUDENTS OF 2025- DEEKSHARAMBH 2025

The Deeksharambh orientation for newly admitted UG and PG students was conducted between July 25-31, 2025. The Orientation opened with the inauguration led by Vice Chancellor Prof. Harpreet Kaur. The Dean Academics Dr. Manoj Kumar Singh introduced the teachers, followed by an open house by Madam Vice Chancellor for responding to the queries of students and parents.

Prof. Danixia Cuevas, Visiting Professor from Miami Dade College USA delivered a series of lectures on global skills needed for lawyers and professionals and tips for becoming successful lawyers.

The Orientation was bifurcated into various verticals namely- academic, co-curricular, residential, disciplinary and elemental lawyering skills to enable young admittants to get a 360 degree understanding of the functioning and environment of the University.

The Registrar, Deputy Registrar, and Accounts Officer explained office and administrative processes. Dr. Bipin Kumar and Ms. Sayantani addressed hostel rules and anti-ragging mandates. Dr. Kranti, Dr. Arunabha, and Dr. Vinod introduced extra-curricular activities such as sports, cultural, and ASLC.

Dr. Archi and Dr. Leela outlined examination rules and processes, with Disciplinary Committee discussing general discipline for boys and girls. Ms. Sayantani Bagchi taught how to read a judgment, Dr. Siddharth, Mr. Sarthak, and Mr. Aniruddh covered mooting, arbitration, and debating; Dr. Rashmi Mathur discussed how to write; UG Council and CPGLS explained attendance modalities; Dr. Vinod D. and team presented library resources, Dr. Renjith Thomas spoke on how to think, the Students Welfare Board detailed health, mess, and counselling facilities, and Dr. Kranti's team delivered POSH training. Ms. Anchal Bhatheja from Vidhi Centre provided training on disability rights and sensitization and RICC outlined internship and placement modalities.

Dr. Mahendra Soni sensitized participants on the NDPS Act, Dr. Vinod D. and team covered online repositories, a panel on "Navigating the Digital Landscape" featured Prof. Danixia Cuevas, Dr. Manisha, Dr. Renjith, Dr. Anand, Ms. Kritika, and Ms. Preeti, Dr. Sucheta Boora conducted DEI sensitization while Farhan Zia, Ms. Preeti, and team concluded with PRIDE sensitization.

9. ORGANIZATION OF CONCLAVES, SYMPOSIUMS & CONFERENCES

A. Vice-Chancellors' Conclave on the Future of Legal Education in India

The University hosted a two-day conclave on January 18–19, 2025 with 22 Vice-Chancellors of Law schools making it a grand conglomeration of visionary leaders, policymakers, and academic experts from across the nation. The inaugural session was graced by Chief Guest Justice Surya Kant, the then Judge and now Chief Justice of the Supreme Court of India, Guest of Honor Justice Sandeep Mehta, Judge, Supreme Court of India, and the then Chancellor of NLUJ and Chief Justice of Rajasthan High

Court Justice M.M. Srivastava. Guided by the visionary leadership of Madam Vice Chancellor Prof. Harpreet Kaur, the objective of the conclave was to encourage collaborative dialogue, foster practical perspectives, and pave the way for transformative policies in the field of legal education. To commemorate the occasion, a special edition of the University's flagship journal NLUJ Law Review was released giving the scholarly perspective of the participating Vice Chancellors.

B. Third Edition of Ambedkar Jayanti Conclave

The Constitutional Law Society organized the Third Edition of its Annual Ambedkar Jayanti Conclave on April 14, 2025, centred on the theme "Dr. Ambedkar and Constitutional Morality." The conclave featured insightful deliberations on the importance of embodying constitutional values within institutions and in daily life.

Dr. Yogesh Mishra underscored the need for institutional reforms to realize constitutional morality in practice. Mr. Shubhendu Shekhar explored the tension between constitutional principles and prevailing societal norms. Ms. Shreyasi Bhattacharya provided a historical overview of constitutional morality, tracing its journey from the debates of the Constituent Assembly to present-day jurisprudence. Mr. Rajesh Ranjan emphasized the vital role universities play in fostering a constitutional ethos, while Prof. (Dr.) Shilohu Rao introduced the concept of data constitutionalism and its relevance to upholding constitutional values in the digital era. Finally, the participants presented some queries to the guest speakers and identified key areas for further exploration.

C. IX CARTAL Conference on International Arbitration

The IX CARTAL Conference on International Arbitration was hosted on 24-25 May 2025 by the Centre for Advanced Research and Training in Arbitration Law bringing together a diverse and highly esteemed group of scholars, institutional leaders and practitioners, to examine the present challenges and future trajectories of international arbitration. Structured around the forward-looking theme, "Reconciling Tradition with Innovation: Future-Proofing the Dispute Resolution Processes," the conference unfolded over two sessions, each tackling a critical dimension of modern arbitration. Panel I explored the evolving landscape of institutional arbitration with a focus on legal frameworks and procedural efficiency, while Panel II addressed the transformative impact of emerging technologies, particularly artificial intelligence, on the arbitration process.

D. III NLUJ-Trilegal Corporate Law Review Summit

The Journal on Corporate Law & Governance (JCLG) organised the III NLUJ-Trilegal Corporate Law Review Summit, 2025 on 8–9 November, 2025. Sponsored by Trilegal and supported by SCC Online–SCC Times as Knowledge Partner, the Summit served as a premier academic platform for dialogue on emerging issues in corporate and commercial law.

Over two days, the Summit brought together leading academics, regulators, practitioners, and students for insightful panel discussions and competitive paper presentations, fostering substantive engagement between theory, policy, and practice. The panel discussions took place on topics of contemporary interest including AI, Automation, and Accountability: Reimagining Fiduciary Duties in the Digital Boardroom and ESG, Climate Governance, and Stakeholder Capitalism: Reassessing Corporate Responsibility.

E. International Symposium on Labour & Employment Laws

The Centre for Research in Labour & Employment Laws, NLU Jodhpur organized the International Symposium On Labour & Employment Laws in collaboration with the International Labour Organisation (ILO), National Labour Law



Association (NLLA), Friedrich-Ebert-Stiftung (FES), Indian Industrial Relations Association (IIRA), and Khaitan & Co. between 15–16 November, 2025. The symposium convened eminent scholars, practitioners, trade union leaders, and international organisations to deliberate on the future of labour regulation in a rapidly digitalising economy. The symposium, structured across four technical sessions alongside four thematic paper presentation panels, examined contemporary challenges ranging from the interplay of central and state labour laws to the rights of gig workers, digital transformation of the enforcement architecture, and the constitutional implications of algorithmic management.

Keynote speeches were also delivered by:

- (a) Dr. Elena Gerasimova, ILO–DWT South Asia, who discussed global trends in labour market digitalisation and emerging regulatory responses.
- (b) Prof. (Dr.) Devinder Singh, Vice-Chancellor, NLU Sonepat who analysed structural gaps in the Indian regulatory framework, especially in the context of the new labour codes.
- (c) Mr. Deepak Kumar, Partner, Khaitan & Co. who highlighted evolving employer obligations and the increasing significance of techno-legal compliance frameworks.

Fraternal addresses were presented by Mr. Anup Srivastava (FES-India) and Dr. Pravin Sinha (NLLA), each highlighting the centrality of social dialogue in times of technological transition.

10. TRAINING PROGRAMMES AT THE UNIVERSITY

A. NLUJ-ITEC Special Training Programme on Artificial Intelligence and Emerging Technologies

The University hosted the 23rd edition of the flagship Indian Technical and Economic Cooperation (ITEC), Ministry of External Affairs, Government of India Special Training Programme on Artificial Intelligence and Emerging Technologies for attorneys from the Office of the Attorney General of Nepal between 10 and 23 February, 2025. The special programme focussed on Artificial Intelligence and Emerging Technologies, and covered law, policy and procedure and multi-dimensional approach to artificial intelligence. It included sessions by legal luminaries and renowned experts and interactive sessions for critical understanding of participants. The pedagogy of lectures was based on case studies and discussion. The inaugural ceremony was graced by the presence of Shri Gaurav Agarwal, IAS, District Magistrate and Collector, Jodhpur.

B. One-Day Workshop on the Maintenance and Welfare of Parents and Senior Citizens Act, 2007

The Centre for Gender Studies and Centre for Family Law, in collaboration with the National Institute of Social Defence under the Ministry of Social Justice & Empowerment organized a One-Day Workshop on the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 (MWPSC) on 29 March, 2025. Insightful sessions were delivered on constitutional protections, financial security, and combating elder abuse, equipping participants with actionable knowledge to navigate legal systems and assert their rights under the MWPSC Act.

The workshop sought to bridge the legislative intent of the MWPSC Act with practical implementation, emphasizing collective responsibility toward elder welfare. Interactive discussions and case studies highlighted solutions to address challenges such as social isolation, financial vulnerability, and lack of awareness.

C. Workshop on Mental Health Matters

The Student Welfare Board organized a two-phase workshop titled "Mental Health Matters" on the 3rd and 4th of April, 2025, for the students of the University. The initiative aimed to introduce participants to essential concepts related to mental well-being, stress, trauma, and self-care practices. The sessions were facilitated by Dr. Sheetal Lakhani (Ph.D., NIMHANS; M.Phil., IHBAS), a Clinical Psychologist and Supervisor, and Dr. Gargi S. Kumar (Ph.D., IIT Bombay; M.Phil., Cancer Institute, Chennai; M.Sc., Central University of Hyderabad). Their combined expertise created a rich and insightful learning environment. The workshop sought to raise awareness about mental health, dispel common myths, and provide students with practical tools for emotional and psychological resilience.

D. II-NLUJ – IITJ National Workshop on Law and Technology

The second edition of the National Workshop on Law and Technology was successfully organized on the 5-6 April, 2025 through a collaborative initiative between NLUJ and the Indian Institute of Technology, Jodhpur (IITJ). Structured across six technical sessions spanning across two days, the workshop examined contemporary challenges such as Artificial Intelligence in judicial systems, Cybercrime Mitigation, protection of Intellectual Property Right in the digital age, regulatory frameworks in Fin-tech and Med-tech among others.

With a galaxy of academia, legal luminaries, technical experts and practitioners, the two-day workshop provided a rare and valuable space for constructive dialogue across disciplines. For students, it was a unique chance to listen to and interact with professionals shaping the future of law and technology in India. For academics and regulators, it offered a snapshot of the urgent issues demanding attention. The workshop also catalysed several important institutional connections, paving the way for future collaborations, pilot projects, and joint research initiatives between NLUJ, IITJ, and external organisations.

E. Awareness Program on Drug-Free Campus

An awareness drive to educate students on drug abuse and its legal and personal consequences was organized on April 7, 2025. The event aimed to raise awareness about the prohibition, use, sale, and possession of narcotic drugs and psychotropic substances under the NDPS Act. It formed part of a broader initiative to educate youth on the growing threat of drug abuse and to promote a healthy, disciplined, and responsible lifestyle among students. Shri Ghanasyam Soni, IRS (CBIC), Zonal Director, Jodhpur & Jaipur (Rajasthan), addressed the gathering, shedding light on commonly found drugs in urban and semi-urban settings and their harmful short- and long-term effects on physical health, mental well-being, academic performance, and social life.

F. Capacity Building Programme in collaboration with PFMTI

The University, in collaboration with the Public Financial Management and Training Institute (PFMTI), Jaipur, Government of Rajasthan, successfully concluded a two-day capacity building programme on Contract Drafting and Contract Management System, held on May 21-22, 2025 at the University campus. During the training, a special session was delivered by Hon'ble Justice Vineet Kothari, former Acting Chief Justice of the Gujarat High Court.

11. SPECIAL LECTURES

A. Special Lecture Series on Water Law & Policy

The University hosted a Special Lecture Series on "Water Law and Policy" from 15th to 19th January, 2025 by Prof. Dr. Philippe Culletis, Professor of International and Environmental Law at SOAS University of London. On the first day, Prof. Culletis introduced the themes of water justice, water security and river rights. Subsequently, Prof. discussed the fundamental right to water and the social movements around water as well as sectoral and transborder conflicts.

The series was engaging and insightful with scope for developing water related research in the university.

B. Expert Session on the Minnesota Law LLM and Institutional Synergies

Professor Kara Galvin, Director, International and Graduate Programs, University of Minnesota Law School, conducted a session on "Minnesota Law School LLM Program and possibilities of partnership with NLUJ" on February 25, 2025.

C. Lecture on India & Bilateral Investment Treaties

The Centre for Policy and Research in International Law organised an Expert Lecture by Prof. (Dr.) Prabhash Ranjan, Assistant Dean, O.P. Jindal Law School on the topic of 'India and Bilateral Investment

Treaties' on March 21, 2025 at the National Law University, Jodhpur. The lecture focused on the progression for policies of investment from 1960s to 1990s. The speaker emphasised on the circumstances leading to the Liberalisation, Globalisation and Privatisation in 1991 and its impact on foreign investment. The discussion progressed onto the clauses adopted in the Model BIT by India and the reasoning underlying the same with specific emphasis on the impact of cases like the White Industries case.

D. Guest Lecture on Diversity Equity and Inclusion: Insights from Organizational Behavior and Law

An online guest lecture by Ms. Vidhi Thakur, Head of Talent Management, DEi & Employee Experience at KFC India, was conducted on April 19, 2025, for students of the UG VIII Semester elective on Diversity, Equity and Inclusion. She shared insights on KFC's flagship DEi program KFC Kshamata, highlighting inclusive hiring, Indian Sign Language training and leadership pathways for employees with disabilities.

12. INTERNATIONAL COMPETITIONS

A. NLUJ International Deal Negotiation Competition in Partnership with A&O Shearman

The University hosted the third edition of NLU Jodhpur International Deal Negotiation Competition in partnership with A&O Shearman from 28 Feb. to 2 March, 2025. Organized by ADRC, the University welcomed 24 teams from India and 4 teams from different countries across the globe for a competitive and intellectually enriching event focused on commercial negotiation intricacies. The Competition was won by The Australian National University with the National University of Singapore as the Runners-Up.

The schedule also featured training sessions led by AOS and ICDR, providing students with a chance to network in a diverse, multicultural environment. A training session was also conducted by Mr. Nabil Shadab, Ms. Aashna Agarwal and Mr. Arun Mal from A&O Shearman. The session covered the practical side of commercial negotiations, in the context of international transactions, and also covered perspectives of finance and due diligence.

B. Regional Rounds of John H. Jackson Moot Court Competition

The West and South Asia Regional Rounds of the 23rd John H. Jackson Moot Court Competition (Regional Rounds) were held at NLU Jodhpur from 7-10 March, 2025. The event witnessed participation by 19 teams from across India and beyond borders all brought together by their shared commitment to excellence in international trade law and dispute resolution. The Chief Guest for the Inauguration, Prof. Murali Kallummal, delivered an engaging speech, drawing attention to the growing relevance of international trade law in shaping economic policies and resolving cross-border disputes.

The event also witnessed participation by representatives from ELSA International, namely Ms. Aliena Trefny and Ms. Gia, the Vice President in charge of Competitions at ELSA and Director of Competitions, who brought the perspective of ELSA's global mission. Ms. Aliena Trefny addressed the audience, speaking on the transformative role of the Regional Rounds in shaping the next generation of international trade law practitioners.

The event was sponsored by Platinum Sponsors, Centre for Trade and Investment Law and Lakshmikumaran and Sridharan attorneys (LKS); Gold Sponsors, Sarvada Legal and the Centre for WTO Studies; Knowledge Partners, SCC Online & SCC Times; Global Sponsors, Van Bael & Bellis, Steptoe LLP, and Baker McKenzie; in association with World Trade Organization.

13. NATIONAL COMPETITIONS

A. XVI NLUJ Antitrust Law Moot Court Competition, 2025

The XVI edition of the NLUJ Antitrust Law Moot Court Competition, 2025 was organized in collaboration with the Competition Commission of India and Cyril Amarchand Mangaldas and held from March 28 to 30, 2025. Recognized as India's premier moot court event focused on competition law, the competition provided a platform for rigorous legal debate and advocacy, attracting participation from law students

across the country. The competition brought together over 36 teams from prestigious law schools across India, offering them a unique platform to hone their legal research, drafting, and courtroom advocacy skills. National Law School of India University, Bangalore (NLSIU) emerged as the winning team of the competition, while the Runners-up team was Jindal Global Law School, Sonipat (JGLS).

14. FACULTY DEVELOPMENT PROGRAMMES

A. Faculty Development Programme on Research and Publications in Law

The University organized a Faculty Development Programme on Research and Publications in Law on 22 March, 2025, featuring Prof. (Dr.) Prabhash Ranjan, Vice Dean (Research) at Jindal Global Law School. The session offered valuable insights into journal selection, enhancing research quality and navigating the publication process. He also shared practical strategies for identifying impactful research topics and engaging with global academic platforms.

B. Faculty Development Programme on “The Balancing Act”

A Faculty Development Programme titled ‘The Balancing Act’ was conducted on 4 April, 2025 by Dr. Sheetal Lakhani and Dr. Gargi S. Kumar for the faculty members. The session was structured around three core segments: Setting the Context, Psychological First Aid – Responding to Crisis Situations, and a Customized Discussion. The programme began with an engaging and interactive discussion, where faculty members reflected on their roles and the challenges they encounter while supporting students. Participants highlighted common mental health concerns among students, including anxiety, hesitation in seeking help, and academic performance pressure. The session also focused on distinguishing between crisis and non-crisis situations, laying the foundation for appropriate and timely interventions.

C. Faculty Seminar by Prof. Bruce Wardhaugh from Durham Law School

Prof. Bruce Wardhaugh, Professor of Competition Law at Durham Law School and Visiting Professor at NLUJ delivered a faculty seminar on his working paper titled: “Against Fairness: Redistribution, Bigness and the purpose of Antitrust” on 30 April, 2025. The seminar was followed by extensive deliberations with faculty giving inputs on the various facets to be included in the working paper.

D. FDP on AI & Legal Education

The IQAC & FDP Committee at NLU Jodhpur organized a Faculty Development Programme on Artificial Intelligence & Legal Education from 14 to 21 July, 2025. The Resource Person for the FDP was Prof. Danixia Cuevas, Professor of Law from Miami Dade College, Fulbright Scholar and Visiting Professor at NLUJ. Professor Cuevas has 26 years of experience in integrating technology with legal education and conducting workshops on educational pedagogy and interactive learning. The FDP was a timely intervention emphasizing upon the transformative potential of Artificial Intelligence in reimagining teaching and learning in legal education. The FDP was structured around the following verticals :

Day 1 : Introduction to Teaching with AI / Syllabus Revisions.

Day 2 : AI for Module Design.

Day 3 : Academic Integrity – Cheating and Detection .

Day 4 : AI and Classroom Activities, Assignments, and Assessments.

Day 5 : Capstone Projects and Implementation Planning.

E. FDP on Pedagogical Practices in Law Schools

The University hosted an FDP on Pedagogical Practices in Law Schools, an area where academic interest across domains converges from 9-11 December, 2025 wherein notable legal academicians shared their perspectives. On Day 1, Prof. (Dr.) S.G. Sreejith, from Jindal Global Law School spoke on ‘The Pedagogical Prudence of Jurisprudence: Selections from the Cookbook of Teaching’ and ‘The Alchemy of Reading: Making Teaching and Writing Possible’. Prof. Amit Bindal from Jindal Global Law School delivered a series of lectures on ‘Teaching Pedagogy for Jurisprudence and Legal Theory’ and ‘Teaching Pedagogy for Criminal Law’. On Day 2, Prof. (Dr.) Harpreet Kaur, Vice Chancellor, NLUJ outlined the contours of ‘Teaching Pedagogy for Commercial Laws’ and Prof. (Dr.) Arul George Scaria, NLSIU, Bengaluru

expounded upon 'Teaching Pedagogy for Intellectual Property Rights Laws'. On Day 3, Prof. (Dr.) M.R.K. Prasad, V.M. Salgaocar College of Law, Goa listed out the 'Teaching Pedagogy for Clinical Legal Education'; Dr. Srinivas Burra, Associate Professor, South Asian University, New Delhi delivered a lecture on 'Teaching Pedagogy for International Law'; Prof. (Dr.) B. 16. ACTIVITY OF CENTERS OF RESEARCH & EXCELLENCE AT NLU

A. Centre for Constitutional Law and Administrative Law

- The Centre for Constitutional Law and Administrative Law, National Law University, Jodhpur, observed Constitution Day 2025 on 26 November, 2025, by organising an intra-university Extempore Moot Court Competition. The competition required participants to address constitutional issues without prior preparation, encouraging clarity of thought, precision in argumentation, and responsiveness to constitutional questions. The problem themes were drawn from contemporary constitutional developments, ensuring relevance to ongoing legal and political discourse.

The team comprising Karlo Cruz and Gauraansh Arora secured the first position. Ms. Sai Deekshita Vijayakumar and Ms. Priyankashri A were declared runners-up. Ms. Sai Deekshita Vijayakumar was also awarded Best Speaker in recognition of the clarity, structure, and coherence of her submissions.

- CCAL-PRIDE Guest Lecture by Prof. Rehan Abeyratne:
The Centre for Comparative Constitutional Law and Administrative Law (CCAL), in collaboration with PRIDE NLUJ, organized a virtual guest lecture with Prof. Rehan Abeyratne, Professor and Associate Dean (Higher Degree Research) at the Western Sydney University School of Law. The lecture, held to commemorate the 7th anniversary of the landmark decision in *Navtej Singh Johar v. Union of India* (2018), proved to be an intellectually stimulating and deeply insightful session.

Prof. Abeyratne drew from his latest book, *Courts and LGBTQ+ Rights in an Age of Judicial Retrenchment*, offering a nuanced examination of the paradox between the judicial advancement of LGBTQ+ rights and the simultaneous decline of liberal constitutionalism across the globe.

B. Centre for Family Law

A grant of 3 lakhs was sanctioned to the Centre by the University under its new initiative to promote a research culture and encourage quality research output. The project, titled "Assessing the Efficacy of the Family Courts: A Case Study from Rajasthan," is headed by Ms. Preeti Badola as the Principal Investigator, along with her team of students.

C. Students' Welfare Board

- Caretaker Sensitization Program – Addressing Student Needs- This program was designed to enhance caretakers' empathy and professionalism in handling diverse student needs.
- Workshop: "Mental Health Matters" - A two-day workshop focused on building awareness and resilience around mental health.

- Awareness Program: "Drug-Free Campus"- An awareness drive to educate students on drug abuse and its legal and personal consequences.

- Publication of the Wellness Booklet | 2025

In August 2025, the SWB of NLUJ marked an important step in strengthening student well-being with the publication of its Wellness Booklet. Designed as a gateway to mental wellness, the booklet serves as a comprehensive guide to support students throughout their academic journey. D. Centre for Economics, Law and Public Policy (CELP)

Participants submitted original essays exploring India's developmental challenges and opportunities, with suggested sub-themes including justice reforms, technology and access to justice, the demographic dividend, women's empowerment, agriculture, innovation ecosystems, sustainability, digital governance, and village empowerment.

- *Guest Lecture by Dr. Ravi Bhandari*

The Centre for Economics, Law and Public Policy hosted a guest lecture by Dr. Ravi Bhandari, Visiting Chair, Planning Commission (State of Karnataka), Professor of Eminence at MSRUAS, and Senior Fulbright Scholar, on 1st October, 2025. Speaking on the theme "Why the Recent Nobels' Age-Old Anglo-Centric & Eurocentric Thesis of Western Property Rights Fail to Understand 'Why Nations Fail,'" Dr. Bhandari critically examined dominant Western interpretations of property rights and their limitations. He highlighted how these frameworks often overlook deeper institutional, economic, and social determinants that shape national success or decline, and he offered alternative analytical perspectives that more comprehensively explain development trajectories.

The Centre conducted an insightful interview with Mr. Mardia, an accomplished alumnus of our very own National Law University, Jodhpur, delving into his journey from a law student at NLUJ to an independent practitioner at the Rajasthan High Court, Jodhpur. I. School of Insurance Studies

- Special session by Ms. Shikha Hassani, Vice President at Willis Towers Watson and a proud alumna of our university, was organised on 21st March, 2025. Ms. Hassani delved into the Significance of Liability and Cyber Insurance, emphasizing their growing importance in today's risk landscape. The risk inspection focuses on identifying operational, financial, compliance, and reputational risks. Effective risk management enhances profitability, resilience, and competitive advantage.
- On 7 November, 2025 the MBA I and MBA III students were taken to M/s. Uma Packaging Industry Jodhpur. The industry manufactures Food-grade packaging pouch operate in a high-compliance, high-liability environment. The executives of the industry explained complete manufacturing process and different risks associated with the packaging industry.

17. RESEARCH PROJECTS

- A. Project Prism granted for a period of 2 years to the Legal Aid & Awareness Committee (LAAC) based on a detailed proposal submitted to the Azim Premji Foundation for a grant. Based on the theme of strengthening access to justice for undertrial prisoners, the project focuses on addressing delays caused by lack of legal aid, administrative gaps, and socio-economic vulnerabilities. Project PRISM is set to begin as a phased initiative aimed at improving access to justice and safeguarding the rights of undertrial prisoners.
- B. Project Ability Empowerment has commenced pursuant to the directions of the Supreme Court in *Reena Banerjee & Anr. v. Government of NCT of Delhi & Ors.*, eight National Law Universities (NLUs) were entrusted with the responsibility of collecting and compiling data on institutions providing care to Persons with Disabilities (PWDs) across designated States and Union Territories. NLUJ is one of the eight NLUs assigned this task and is responsible for data collection in Rajasthan, Gujarat, and the Union Territories of Daman and Diu, and Dadra and Nagar Haveli.
- C. Project on assessing trade in services of five leading states of India- Rajasthan, Haryana, Maharashtra, Gujarat and Goa under the guidance of Ministry of Commerce, Govt of India, New Delhi.

18. FACULTY ACHIEVEMENTS

23. NLUJ LIBRARY REPORT

1. Collection Development

During the year 2025, the library added 873 new books including textbooks, reference works, bare acts, commentaries, and research monographs. Procurement followed the Library Collection Development Policy through empanelled vendors. Focus areas included emerging legal domains (AI governance, cyber law, competition law, environmental law, international arbitration), updated core texts, and authoritative research commentaries. It has also subscribed 23 print journals and magazines for the University Library.

2. Implementation of Shodhganga

The library initiated systematic uploading of awarded Ph.D. theses to Shodhganga (INFLIBNET) after obtaining scholar consent. Seven Ph.D. theses were processed with standardized metadata and compliance checks, ensuring adherence to UGC regulations and enhanced research visibility.

3. Institutional Repository Implementation

An Institutional Repository using DSpace was implemented to preserve and disseminate faculty publications, journals, theses, research reports, and media records, improving discoverability and institutional visibility.

4. Computer Lab Enhancement for AIR Access

The process for procuring and installing five computers in the Computer Lab has been initiated to provide dedicated access to AIR Offline Databases and strengthen case law research facilities.

5. Implementation of ONOS (One Nation One Subscription)

The University adopted ONOS, enabling cost-free access to national and international scholarly journals, reducing duplication and strengthening research and literature review.

6. Implementation of ShodhChakra

The University has initiated the process for implementing ShodhChakra (INFLIBNET) to support structured Ph.D. supervision through progress tracking, documentation, and enhanced scholar-guide interaction.

7. Training and Capacity Building for Institutional Repository

Training programs were conducted for library staff on DSpace workflows, metadata standards, and digital preservation to ensure sustainable repository management.

8. Research Support and Alert Services

The library continued Turnitin services, database alerts, case law updates, and new arrival notifications to support research quality and academic integrity.

9. Journal Outreach Service

Journal outreach initiatives were undertaken to enhance awareness, indexing coverage, and citation impact of university journals.

10. Renewal of the databases. The University renewed its electronic resources like SCC Online, Kluwer Arbitration Law online, Hein Online, LexisNexis advanced, Manupatra, Westlaw and EBC Reader, Journal of World Trade and Live Law portal. The total number of subscribed e-journals are more than 8000. Apart from the above E-resources the University subscribed to Casemine, Oxford e-books, My Loft (Remote access Service) and Turnitin (Anti plagiarism database). The University library is also member of ONOS scheme of government of India. The University also renewed the e subscription of Hindu e paper and Business line.

11. Facilities for the Specially abled: The university library provides specialized facilities for students with disabilities, including access to screen-reading software such as JAWS, the Pearl Book Reader, and the Angel Pro listening device. Additionally, the library is equipped with separate ramps for easy access and scanning equipment to assist specially abled students. The university has signed an MoU with the Rajiv k Luthra foundation for setting up a state of art Accessibility Lab for the specially abled students in the University library.

24. DAY ZERO REPORT- BATCH OF 2026

The University successfully concluded Day Zero for the Batch of 2026, held from August 04, 2025–August 05, 2025. A total of 27 offers were received by the students, which resulted in 20 accepted job offers from 13 participating law firms.
