

CONCEPT NOTE

Recent amendments in labour and employment laws at both Central and State levels aim to improve ease of doing business. The enactment of four Labour Codes by the Central Government, consolidating 29 existing legislations, is yet to be fully implemented due to the subject falling under the Concurrent List of the Constitution. Consequently, several States have enacted their own laws and issued government orders.

This conference aims to explore:

- The impact of new labour laws on workplace rights and conditions of work.
- Ways to safeguard existing rights amid legislative changes.
- Emerging challenges in the informal economy, gig work, and platform-based employment.
- The role of digital technology in spreading awareness and improving enforcement of labour laws.

Conference Objectives:

- 1. Examine the interplay of Central and State labour laws with Constitutional provisions.
- 2. Discuss the evolving informal economy and gig work regulations.
- 3. Analyze the use of ICT/digital tools in law enforcement and compliance.
- 4. Generate new insights through papers, panel discussions, and expert deliberations.
